- x) To propose the Code of Ethics for the Institution.
- xi) To organize ways to communicate the Code of Ethics to all staff and students and enhance its understanding.
- xii) To report breaches of the Code of Ethics or non-compliance of ethical practices amongst students, faculty and staff to the Principal.
- xiii) To formulate policies for corrective actions.
- xiv) To coordinate the periodic revision of the Code of Ethics and related implementation mechanisms.
