I am very happy to inform you that your institute is selected by MHRD for providing an LED IR touch Interactive Digital Board. The installation of the equipment is expected in the first week of September 2019. In view of readiness of site, you are requested to ensure the preparedness of your institute on the below-mentioned checklist:

- 1) **Identification of rooms**: Please remember that all the equipment are provided for UG classrooms only and should not be installed in PG Classrooms, Auditorium, Seminar halls, Conference rooms, Cabins, etc. Ensure that every UG department should have at least one such classroom and a sufficient number of First-year classrooms in the institute. You will be provided either max. 10 boards or the number of boards you mentioned in the proposal whichever is less.
- 2) **Positioning of Board**: Digital board shall not replace the blackboard and hence should be placed adjacent (on the same wall) to the blackboard and also visible to every student in the class. The digital board size is 57"x 32" (Landscape), and hence if required the blackboard needs to be shifted accordingly. Appropriate dais arrangement should be made. The wall should be a brick wall/cement wall and should be free from water leakages and direct sun rays.
- 3) **Electric connection**: Minimum 4 Sockets/Switches with 15Amp capacity and fuse arrangement should be available with proper wiring not more than 2 feet away from the board location.
- 4) **Internet connectivity**: LAN connection of at least 1 Mbps connectivity with proper casing and capping with at least 2 I/O boxes and 3 feet patch cord.
- 5) Additional provision as the institute finds appropriate for using other equipment can be made.

All the expenditure incurred against the above-mentioned activities can be booked under IOC under TEQIP-III. If the institute is not able to ensure the above checklist and delays the process of installation unnecessarily, the name of the institute may be withdrawn.
