Conditions:-

1. *The students who were transferred from the University Jurisdiction and other Universities their examination forms should be submitted separately with the approval of the competent authorities like Commissioner of Tech. Education, Govt. of T.S. and Director, Directorate of Academic Audit, O.U. with allotment of H.T.No.s.*
2. *In respect of the candidates who have completed course requirement having appeared for IV/IV-II semester and completed double the duration of course but did not cross 10 years (Regular) and 8 years (Lateral Entry Students) from the date of admission have to pay an additional amount of Rs.1000/- per subject, semester-wise along with normal semester fee and submit N R in duplicate separately login*
