

**Minutes of the meeting of the Board of Governors of Vasavi College of Engineering held at 11.00 a.m. on 28.09.2013 (Saturday) in the Conference Hall, Visvesvaraya Block, Vasavi College of Engineering, Ibrahimbagh, Hyderabad – 500031**

The Chairman BoG welcomed the members to the meeting and the following items were taken up for consideration:

**1. Confirmation of the minutes of the meeting of the Board of Governors of the College held on 17.08.2013:**

The minutes of the meeting of the Board of Governors held on 17.08.2013 were read out and confirmed.

**2. Review of Action Taken Report on the resolutions of previous BoG meeting held on 17.08.2013:**

- i) As resolved vide agenda item No. 3(J) of BoG meeting held on 17.08.2013, a Screening Committee has been constituted (as per the guidelines of NPIU) with the following members to evaluate the applications received from faculty members and to approve for international travel:

Prof. G.V. Ramana Murthy, TEQIP Coordinator will assist the Committee as and when required.

Accordingly, orders were issued vide reference No. VCE/TEQIP-II/S.C. for IT/2013, dated 11.09.2013.

- ii) During the BoG meeting held on 17.08.2013 under item No. 4 (a) & (b) it was resolved to invite Prof. M.R. Madhav, Visiting Professor of IIT, Hyderabad & JNTUH and Prof. T.V. Subba Rao, Vice President, VAE to attend the BoG meetings as members. Both of them have accepted our invitation.
- iii) During the BoG meeting held on 17.08.2013 under item No. 2 (h), it was decided to identify few consultants for the guidance and suggestions from time to time to strengthen the academic activities and overall development of the students. Action is being taken to contact reputed consultants and also local industry experts.



**3. The following points were noted after due consideration:**

i) Grant-in-Aid sanctioned by the AICTE:

The AICTE has provided financial assistance of Rs.2.00 lakhs (Rupees two lakhs only) under "Grants-in-Aid" Scheme to the Department of Information Technology, Vasavi College of Engineering for organizing 3<sup>rd</sup> National Conference on "Computer Networks & Information Security 2014" vide its letter dated 29.07.2013.

ii) Organizing Guest Lectures as a part of Autonomy status to the College:

It was noted that the College has organized the following guest lectures by inviting eminent persons from academia:

a) Dr. C.D. Naidu, Principal, VNRVJIET, Hyderabad visited the College on 17.08.2013 and delivered expert lecture on "Preparation by the college leading to the award of UGC autonomous status to the College".

b) Prof. Anil D. Sahasrabudhe, Director, College of Engineering, Pune delivered a guest lecture on "Autonomy-teachers' Role" on 04.09.2013.

c) It was also noted that

- The College is gearing up for visit of expert committee from UGC to consider grant of autonomous status by having regular weekly meetings to monitor the preparedness of all the departments.
- The college is in the process of identifying the experts from academia/industry to utilise their expertise and inviting them to be members on Board of Studies, Academic Council etc., and
- The departments are also preparing draft syllabus & course structure for all the four years of B.E. Program.

iii) Revised Result Analysis:

It was noted that on subsequent declaration of revaluation results, the pass percentage (percentage of students who have passed all the subjects without any backlog) of 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> year students has improved from 73.45% to 79.33%, from 77.03% to 79.79% and from 75.35% to 78.78% respectively.



iv) Placements:

It was noted that a total number of 46 companies visited the College during 2012-2013 and recruited 476 students from 2012-2013 batch. Further noted that 2013-2014 placement activity has started, reputed companies viz., Microsoft, Deloitte, Mahindra & Mahindra, Factset, ELGI, S & P Capital IQ etc., have visited the campus and as on 31<sup>st</sup> August 2013, 40 students have got placement.

**4. Consideration and approval of activities initiated by the College under S.C. 1.1 of TEQIP-II:**

i) Teaching and research assistantships @ Rs. 8000/- per month to Postgraduate Students:

It was noted that the following are the details of teaching assistantship provided by the College to the students under TEQIP-II:

Note:

The total cumulative expenditure under this category upto 31<sup>st</sup> August 2013 is Rs. 27.92 lakhs.

**It was resolved to ratify the payment of Teaching Assistantships to PG students to a tune of Rs. 27.92 lakhs till now from the start of the programme.**

ii) Ratification of faculty and staff development activities and amount spent so far:

It was noted that to improve the competence of staff, the College has so far conducted 13 inhouse conferences/workshops and also noted that based on the Training Need Analysis (TNA) of each Department, faculty and non-teaching technical staff were deputed to attend training programmes/workshops/conferences. The following are the details regarding amount spent so far towards above activities:

It was resolved to ratify the Staff Development Programme activities carried-out under TEQIP and the amount spent (Rs.23.64 lakhs) upto the end of August 2013.

iii) Interaction with Industry:


It was noted that to improve the Industry-Institute interaction, the College has invited eminent persons from industry to address the students & staff and organized 27 guest lectures upto the end of August, 2013 and spent Rs.6.16 lakhs.

**It was resolved to ratify the enhanced interaction with industry activities carried-out under TEQIP and the amount spent (Rs.6.16 lakhs) upto the end of August 2013.**

iv) Enhancement of Institutional Management capacities:

It was noted that as a part of Institutional Management capacities enhancement, the College has deputed Prof. K. Jaya Sankar, Head, Department of Electronics and Communication Engineering to attend training programme organized by Indian School of Business (ISB), Hyderabad on 2<sup>nd</sup> and 3<sup>rd</sup> September, 2013. Further noted that the other events under this activity which include inviting recruiters for campus placements, sending students to the industries for internships have been carried out and the total expenditure incurred under this activity upto the end of August, 2013 is Rs.74,000/-.

**It was resolved to ratify the Institutional Management capacities enhancement activities carried-out under TEQIP and the amount spent (Rs.0.74 lakhs) upto the end of August 2013.**





v) Implementation of Institutional Reforms:

It was noted that

- a) The College has applied for Accreditation for six of its Undergraduate Programmes. An Inspection Committee of NBA has visited the College in January and February, 2013. The report of the Inspection Committee and grant of accreditation is awaited and
- b) The amount spent upto the end of August 2013 is Rs. 38,000/-.

**It was resolved to ratify the Implementation of Institutional Reforms activities carried-out under TEQIP and the amount spent (Rs.0.38 lakhs) upto the end of August 2013.**

vi) Academic support for academically weak students:

It was noted that the College has a practice of identifying academically weak students during their 2<sup>nd</sup>, 3<sup>rd</sup> & 4<sup>th</sup> year of study and remedial classes are being conducted beyond working hours i.e., from 4.30 p.m. to 6.30 p.m. for those who have failed in certain subjects. In order to identify weak students in the first year, the College conducts a diagnostic test after 4-weeks of commencement of classes and conducts remedial classes for weak students. Further noted that an amount of Rs.32,000/- was spent upto the end of August, 2013.

**It was resolved to ratify the Academic support for academically weak students activities carried-out under TEQIP and the amount spent (Rs.0.32 lakhs) upto the end of August 2013.**

vii) Technical Assistance for procurement and academic activities:

The Member-Secretary, BoG has informed the members that efforts are being made to identify the consultants for taking assistance regarding procurement and academic activities and hopefully complete this activity soon.

viii) Incremental operating cost:

It was noted that under this activity the salaries of staff employed for TEQIP office are covered. Further noted that the TEQIP office has one Accounts Assistant and one Junior Assistant to assist the TEQIP Coordinator to submit the required documents to SPFU and NPIU and an amount of Rs.4.22 lakhs has been spent upto the end of August, 2013 towards incremental operating cost.



**It was resolved to ratify the incremental operating cost activities carried-out under TEQIP and the amount spent (Rs.4.22 lakhs) upto the end of August 2013.**

ix) Ratification of disallowed expenditure:

The Member-Secretary, BoG has informed the members that the SPFU has shown Rs.1,24,166/- as ineligible expenditure for the year 2012-13 based on audit report and communicated its decision through e-mail dated 21.09.2013 and in response to the e-mail the College has provided clarification/justification and requested them for allowing the expenditure. The SPFU has advised the College to discuss in the Board of Governors meeting for approval to enable them to consider this issue.

**After due consideration, it was resolved to ratify the expenditure incurred to the tune of Rs.1,24,166/- as per the details furnished hereunder:**

**5. Other items:**

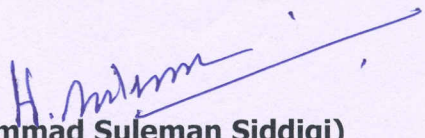
Prof. M.R. Madhav has suggested the following activities for implementation by the College to improve the quality of technical education.

- b) Contact the IITs for permission to allow our students in their institutes for receiving training during summer vacation.

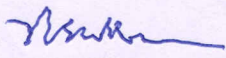


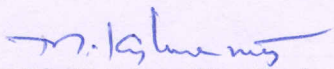
- c) Sri P. Balaji has suggested that efforts should be made to prepare all the documents and manuals required for obtaining UGC autonomous status by end of October 2013.

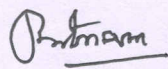
The Chairman ended the meeting after thanking all the members for their active participation.
