SPECIAL INSTRUCTIONS TO THE PRINCIPALS

- The College login will be closed after the last date.
- In case the fee is not remitted to the O.U. A/c. OR if online EAFs are not submitted on or before due date even if fees remitted into fund account within due date. (Late submission of forms by the College beyond the date prescribed attracts penalty @ Rs.1500/- per day and to be borne by the college)
- Principals are requested not to forward/submit the EAF of Not Eligible Candidates. The results of Not Eligible candidates will be cancelled at any stage, if they write the examination.
- The Principals are requested to transfer Consolidated exam fee amount into The Registrar, Examination fee fund, O.U., A/c No. 52198262033 (SBI, O.U. Branch, IFSC Code "SBIN0020071"), O.U. through online payment in EAF login.

Conditions:-

1. *The Students who were admitted during the Academic year 2010-2011 (Regular) and 2012-2013 (later entry students) onwards should submit their examination forms Online through college login. The N.R. should be submitted separately in respect of Regular and Transfer candidates admissions. The hardcopy of the applications submitted through college login be download and submitted to the Examination Branch duly signed by the student and the Principal concerned along with photocopy of qualified examination.*
2. *The students who were transferred from the University Jurisdiction and other Universities their examination forms should be submitted separately with the approval of the competent authorities like Commissioner of Tech. Education, Govt. of T.S. and Director, Directorate of Academic Audit, O.U. with allotment of H.T.No.s.*
3. *In respect of the candidates who have completed course requirement having appeared for IV/IV-II semester and completed double the duration of course but did not cross 10 years (Regular) and 8 years (Lateral Entry Students) from the date of admission have to pay an additional amount of Rs.1000/- per subject, semester-wise along with normal semester fee and submit N R in duplicate separately login.*
4. *As a part of the Core Banking System, all the students are hereby instructed to deposit the Examination Fee into their respective college accounts only for onward transmission to the University by the college.*
5. *All the Principals are requested to verify the eligibility of the students thoroughly and forward the same to this office for the issue of Hall Ticket. If failed to verify the eligibility of the candidates, the principal will be held responsible for the issue of hall ticket to the non-eligible candidates.*
6. ***Not to collect the Exam fee from Visually/Physically Challenged and Hearing Impairment students as per O.U. Order No. 1555/228/2007-08/Budget-V, dated: 25-03-2008. A Xerox copy of medical Certificate confirming their status. (Minimum percentage of disability must be of 40% attached to the application forms.) Visually/Physically Challenged and Hearing Impairment students applications forms should be submitted separately along with separate Nominal Roll.***
7. *Any discrepancies with regards to the Candidate's data such as Internal marks, Practical, Viva-voce and Projects etc. should be brought to the notice of concerned officials of Examination Branch and obtain the acknowledgement within one month of declaration of results. After one month, queries will not be entertained.*
8. ***Due to prevailing situation COVID-19 pandemic, the Principals are advised not to submit hard copies of EAF application forms to the Examination Branch, O.U. The approvals of the forms will be given through online by the concerned sections of the Examination Branch. The Principals can verify the approval status in their College Logins.***
9. *The Principals are required to transfer the consolidated fee amount through Online/NEFT/RTGS for credit in to the "Registrar, O.U. Exam Fee Fund Account". A/C No. 52198262033, State Bank of India (SBI), O.U. Branch, IFS Code"SBIN 0020071".*
10. ***Principals will be held responsible for any lapse in transfer of amount from the banks to the "Registrar, O.U. Exam Fee Fund Account".***
